## **Charles Noyes Chadwick Papers**

## Overview:

Charles Noyes Chadwick (1849-1917) was the oldest surviving child of Daniel Chadwick, Ir., and Ellen Noves Chadwick. Educated at Yale and in Germany, he lived most of the time in Brooklyn but spent holidays and vacations at his parents' home on Ferry Road. He later inherited "the house on the hill" built in 1820 by his grandfather Enoch Noyes on the site of an early Mather house on Ferry Road. In 1873 after a 3-year courtship Chadwick married Alice Ann Caruth, who was born in Virginia and moved to Brooklyn to attend the Packer Institute. Mrs. Chadwick co-founded the first kindergarten in Brooklyn in 1876, which in 1883 was incorporated as the Froebel Academy. Charles and Alice Chadwick are listed as co-founders of the Academy, where he presented several papers on education. He was active in other civic organizations in Brooklyn and a member of its Board of Education from 1896-1899. After working as a commission merchant in lower Manhattan, he founded the C.N. Chadwick Company, which made, among other goods, children's underwaists. In 1905 he was selected to head New York City's Water Board. As commissioner, he designed a system to bring water from the Catskills to New York City's reservoirs. Chadwick died in Brooklyn in 1920. Charles and Alice Chadwick had five children: Charles, Alice, George, Ellen and Mary.
